

OFFICIAL RULES AND REGULATIONS

1. AGREEMENT TO BE BOUND BY RULES:

By participating in this Bala Legion #424 Promotion (the "Promotion") you are signifying your agreement that you have read and agree to be legally bound by the terms and conditions of these Official Rules and Regulations (the "Rules").

2. PROMOTION SPONSOR:
